FENCE REGULATIONS (Ordinance 11-03)

1. Fencing in front yard cannot exceed 36" in height and must be located at least 5' from street or public right-of-way.
2. No fence may be located within a sight triangle (see illustration in Ordinance 11-03).
3. Fences may be located in a utility easement; however, they must have a gate installed on each end the width of the easement. Fences may not be located in a platted drainage easement.
4. Finished surfaces must face outward from the property.
5. Before digging, contact Arkansas One Call (811).

ACCESSORY STRUCTURE REGULATIONS (Ordinance 19-30)

1. No accessory structure shall occupy a lot in which there is no principal dwelling or building.
2. Accessory structures limited to 3 on commercially zoned lots, 2 for most residentially zoned lots, and 2 per unit on multi-family zoned lots.
3. Setbacks: minimum of 3-feet from side property line, 5-feet from rear property line, 8-feet from principal structure, and no closer to the street than the front of the principal structure. If structure is taller than 10-feet or more than 200 SF, different setbacks apply. Please see building inspector.
4. Structure must have a floor space that does not exceed 25% of the floor space of the principal structure.
5. Before digging, contact Arkansas One Call (811).

This permit becomes null and void if authorized work or construction has not begun within six months, or if construction or work is suspended or abandoned for a period of six months, at any time, once work is started.
